
Action should be taken to make tobacco free

Electricity theft of 78 lakh 49 thousand of 13 bungalow owners in Kalyan East has been revealed

Kalyan: The crackdown against electricity thieves has been intensified in one sub-division after Kalyan of Maharashtra. In this campaign, electricity theft by bungalow owners has been exposed and electricity theft of 78 lakh 49 thousand rupees by 13 bungalow owners has been exposed. The power theft detection drive has been intensified on power lines with the most power loss under sub-division one of Kalyan East division. In the months of September and October, theft of Rs 1.37 crore worth of electricity from 13 bungalow owners was caught. This includes electricity theft of Rs 72 thousand which is going on by laying unmetered cable in a single bungalow in Bhat. Electricity theft of Rs 13 lakhs of a jeans factory in Newaji was revealed.

This campaign was carried out in the areas of Newaji, Dhantvan Bhat, Ameer, Vadarali etc. In the month of October alone, action was taken against 59 power thieves in this area and power theft of Rs 68 lakh 47 thousand was exposed.
